Terms and Conditions for Seed Account

These terms and conditions apply to and regulate the operation of the Seed —Account (the "Account") offered by Community Seed Bank. These terms and conditions shall be in addition to any other terms as stipulated by Community Seed Bank from time to time.

1 Definitions

In these terms and conditions, the following words and phrases have the meaning stated hereunder unless indicated otherwise:

- 1.1 "Account Opening Form" (AOF) refers to the relationship form for Seed Account.
- 1.2 "Customer/Members" refers to any person holding an Account with Community Seed Bank.

2. Applicability of Terms

2.1 These terms and conditions form the contract between the Customer/Members and Community Seed Bank. The Customer shall apply to Community Seed Bank in the prescribed form for operation of the Account and availing of the related Services. By applying for opening the Account, the Customer acknowledges that he/ she has read understood and accepted these terms and conditions.

3. Account Opening:

3.1 The account opening formalities are governed by the policies of Community Seed Bank and may be revised from time to time. The Account cannot be opened for business or sell purposes.

4. Operating Accounts:

- 4.1 An Account must be opened in the names of:
- A. An individual in his/her own name as mentioned in ration card. Or
- B. Husband-Wife in their joint names.
- C. In case of joint holding Account, the account will be Operated via Primary Account Holder or Secondary Account Holder.
- D. All the Accounts maintained in the name of an individual shall be operated by the individual
- E. In case of joint holding accounts, any change in operational instructions or any other information with regard to the Account Opening Form is to be given by any one of the joint account holders irrespective of the mode of operation.
- F. The Customer is / are expected to examine the entries in the Account statement on receipt, and draw the attention of Community Seed Bank to any not-errors or omissions that might be discovered. Community Seed Bank does not accept any responsibility for any loss arising out of failure on the part of the Customer to carry out examination of entries in the passbook/statement and to point out such not-error and/or omission within fourteen (14) days from the date of the statement/ updation of passbook.

5. Safe Keep of Pass Book:

5.1 The Customer shall be solely responsible for the safe-keeping of passbook.

6. Conduct of Account:

6.1 Exchange of seed are entertained normally during banking hours at the branch where the Account is maintained. Community Seed Bank shall not be liable for any delay on any account of failure of connectivity.

7. Charges / Fees:

7.1 Charges in connection with the operation of the Account and the Services would be levied at the rates as prescribed by committee of community seed bank.

8. Member of community seed bank

8.1 After successfully approval of the account opening form, account holding member will be treated as member of community seed bank and have right to choose/voting process for five member committee as per rule and regulation of Community Seed.

9.Pass Book / Statement of Account:

9.1 Community Seed Bank will offer, free of cost, entry in the physical passbook at time of exchange of seed.

10. Non-Transferability:

10.1 The Account and the Services provided to the Customer/Member are not transferable under any circumstance and shall be used only by the Customer.

11. Caretaker Organization and Closure of the Account

11.1 The caretaker is community seed management committee of Community Seed bank, reserves the right to close or freeze the Account(s), after due notice to the Customers/Members. This committee reserve the right to any change in rule and regulation of the community seed bank in any time.
